A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF WESTLAKE, FLORIDA, APPROVING THE PARTICIPATION IN THE INTERGOVERNMENTAL PLAN AMENDMENT REVIEW COMMITTEE AND AUTHORIZING THE MAYOR, WITH ATTESTATION BY THE CITY CLERK OF THE CITY OF WESTLAKE, TO EXECUTE THE COMPREHENSIVE PLAN AMENDMENT COORDINATED REVIEW INTERLOCAL AGREEMENT AND MULTI-JURISDICTIONAL ISSUES COORDINATION FORUM AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, PART I of Chapter 163, Florida Statutes, permits public agencies as defined therein to enter into interlocal agreements with each other to jointly exercise any power, privilege or authority which such agencies share in common and which each might exercise separately; and

WHEREAS, the Comprehensive Plan Amendment Coordinated Review Interlocal Agreement establishes an intergovernmental coordination program for reviewing proposed changes to adopted comprehensive plans which fully utilizes the existing the Chapter 163 comprehensive planning process with minimal bureaucracy and expense for the participants; and

WHEREAS, the Multi-Jurisdictional Issues Coordination Forum Agreement establishes a vehicle for consensus building through the identification and possible resolution of multi-jurisdictional issues; and

WHEREAS, the City Council of the City of Westlake, Florida, in the spirit of cooperation and as an expression of its commitment to the betterment of Palm Beach County as a whole, desires to become a participant in the Comprehensive Plan Amendment Coordinated Review Interlocal Agreement and a member in the Multi-Jurisdictional Issues Coordination Forum Agreement.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF WESTLAKE, FLORIDA, AS FOLLOWS:

- **Section 1:** The forgoing recitals are hereby affirmed and ratified.
- Section 2: The City of Westlake, Florida hereby agrees to terms and conditions of that certain Comprehensive Plan Amendment Coordinated Review Interlocal Agreement and that certain Multi-Jurisdictional Issues Coordination Forum Agreement, copies of which are attached hereto as Exhibit "A" and Exhibit "B", and which is incorporated herein by reference, and which is authorized pursuant to Section 163.01 Florida Statutes.

Section 3: The Mayor, with attestation by the City Clerk, is authorized to execute said Agreements.

Section 4: This resolution shall take effect immediately upon its adoption.
