39	privately owned vehicle is utilized for official travel in lieu of
40	publicly owned vehicles or common carriers, the traveler shall be
41	entitled to a mileage allowance based upon the then current
42	optional standard mileage rate for computing the deductible cost of

It is the intention of the City Council of the City of Westlake that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of the City of Westlake, Florida, and that the Sections of this Ordinance may be renumbered, re-lettered and the word "Ordinance" may be changed to "Section," "Article" or such other word or phrase in order to accomplish such intention.
