The proposed millage rate will be reflected in the Palm Beach County Appraiser TRIM Notice, which shall serve to notify all property owners of a public hearing to be held on the $\underline{\mathbf{5th}}$ day of September 2023 at $\underline{\mathbf{6pm}}$ for the purposes of hearing objections or criticisms of the tentative budget and millage to be presented at that time.
