1 ORDINANCE NO. 2023-03 2 AN ORDINANCE OF THE CITY COUNCIL FOR THE CITY OF WESTLAKE, FLORIDA, 3 AMENDING ORDINANCE NO. AS SET FORTH IN THE CITY'S CODE OF ORDINANCES; PROVIDING FOR THE CREATION OF SECTION 4 TO BE ENTITLED 5 TREATMENT CENTER **DISPENSING** "MEDICAL MARIJUANA **FACILITIES** PROHIBITED"; PROVIDING FOR PURPOSE AND FINDINGS; PROHIBITING MEDICAL 6 MARIJUANA TREATMENT CENTER DISPENSING FACILITIES WITHIN THE CITY OF 7 8 WESTLAKE; PROVIDING FOR CODIFICATION, PROVIDING FOR CONFLICTS; 9 PROVIDING FOR SEVERABILITY, AND PROVIDING AN EFFECTIVE DATE. 10 11 WHEREAS, Art. X, § 29, Fla. Const., entitled, "Medical Marijuana production, 12 possession and use," was passed by the electors of Florida in November 2016, and amended the Florida Constitution to allow the use of marijuana in certain medical 13 14 applications; and, 15 16 WHEREAS, Art. X, § 29, Fla. Const. defines Medical Marijuana Treatment Centers 17 ("MMTCs") to mean an entity that acquires, cultivates, possesses, processes (including development of related products such as food, tinctures, aerosols, oils, or ointments), 18 transfers, transports, sells, distributes, dispenses, or administers marijuana, products 19 20 containing marijuana, related supplies, or educational materials to qualifying patients or 21 their caregivers and is registered by the Department (of Health); and, 22 23 WHEREAS, the City Council, pursuant to the authority provided to the City in Section 381.986(11), Florida Statutes, desires to prohibit MMTCs from establishing 24 25 dispensaries within the municipal limits of the City of Westlake. 26 27 NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY FOR THE CITY OF 28 WESTLAKE, FLORIDA, AS FOLLOWS: 29 30 SECTION 1. Recitals. The foregoing recitals are confirmed, adopted and 31 incorporated herein and made a part hereof by this reference. 32 The City Council hereby amends Ordinance No. _____ by amending Article ____ by specifically creating Section ____ entitled "Medical Marijuana Dispensing 33 Facilities Prohibited" to read as follows: 34 35 36 Sec. ______. - Medical Marijuana Treatment Center Dispensing Facilities Prohibited. 37 38 (a) Purpose. It is the purpose of this ordinance to prohibit Medical Marijuana 39 Treatment Centers created under Art. X, § 29 of the Florida Constitution from establishing Medical Marijuana Treatment Center Dispensing 40 Facilities within the municipal limits of the City of Westlake: 41 (b) Findings. Based on authority granted to municipalities in Section 42 43 381.986(11) Florida Statutes, the City Council finds that a ban on the

7	SECTION 3. Codification. It is the intention of the City Council of the City of
8 9	Westlake that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of the City of Westlake, Florida, and that the Sections of this Ordinance may
10	be renumbered, re-lettered and the word "Ordinance" may be changed to "Section,"
11	"Article" or such other word or phrase in order to accomplish such intention.

13	SECTION 4. <u>Conflicts</u> . All ordinances or parts of ordinances, resolutions or
14	parts of resolutions which are in conflict herewith, are hereby repealed to the extent of
15	such conflict.
16 17	SECTION 5. Severability. Should the provisions of this ordinance be declared to be
18	severable and if any section, sentence, clause or phrase of this ordinance shall for any
19	reason be held to be invalid or unconstitutional, such decision shall not affect the validity
20	of the remaining sections, sentences, clauses, and phrases of this ordinance but they shall
21	remain in effect, it being the legislative intent that this ordinance shall remain
22	notwithstanding the invalidity of any part.
23	
24	SECTION 6. Effective Date. This ordinance shall be effective upon adoption on
25	second reading.
